# 3. Consultation and Adoption

Stakeholder consultation and public engagement played an integral role in the development of the shoreline management policy options. The aim of the engagement strategy was to assist in the delivery of a publicly acceptable and practicably deliverable SMP that considered, wherever possible, wider social and environmental issues in the context of flood and coastal erosion risk.

The SMP was overseen by a **Client Steering Group** (CSG) comprising a range of authorities and organisations:

- Monmouthshire County Council
- North Somerset District Council
- Bristol City Council
- South Gloucestershire Council
- Stroud District Council
- Forest of Dean District Council
- Newport City Council
- Cardiff City Council

An **Elected Member Forum** (EMF) was established to represent the public. The EMF comprised elected member representatives from client local authorities, IDBs, and members of the EA's Regional Flood Defence Committee (and the relevant equivalent in Wales with responsibility for coastal flooding). Members were involved from the beginning of the development process, with a view to minimising the risks of producing a document with policy options that were not subsequently approved by the operating authorities. The members were involved through a forum, building trust and understanding with the Client Steering Group. The EMF fully endorses the plan's findings and was instrumental in obtaining Local Authority approvals.

At various stages in the SMP, advice was sought from key stakeholders in order to inform the preparation of the SMP. Key stakeholders were considered to be those organisations and individuals directly affected by coastal processes along the SMP frontage over the next 100 years.

Around 200 key stakeholders were identified including those with the following interests:

- conservation and wildlife (eg. RSPB, Forestry Commission)

- cultural and historic interests (eg. English Heritage, Glamorgan Gwent Archaeological Trust)

- commercial interests (eg. Powergen, Network Rail)

- leisure and amenity (eg. Welsh Yachting Association, Corus)

#### 4. Quality and Environmental Criteria

#### Statement of Compliance with Guidance

This SMP was issued as a draft for consultation in late 2009 and was initially reviewed at this stage by the EA's Quality Review Group (QRG) and comments passed back to the CSG for consideration and response. This process was repeated until the CSG had provided satisfactory responses to all QRG comments, and was completed in November 2010. At this stage it was concluded that the plan is generally in line with the Shoreline Management Plan (SMP) Guidance Note. Policy appraisal techniques have been satisfactorily applied and the plan sets out sustainable policy options for the three prescribed epochs (short, medium, long term) based upon technical, environment, economic and social assessments. The plan also sets out the findings in the required format. Procedures have been followed for:

- developing an overall understanding of the coast;
- identifying and analysing problems;
- engaging stakeholders at appropriate stages;
- · developing policy in line with current guidance; and
- making sure the SMP meets the principles of sustainable development.

The attached Completion Report (Item 4) addresses the questions set out in the SMP Guidance Note, and has been completed by Monmouthshire County Council as lead authority.

#### **Environmental Assessment**

# Strategic Environmental Assessment

A stand-alone Strategic Environmental Assessment (SEA) report is provided at Appendix I, part A. The SEA is compliant.

In addition, a Statement of Environmental Particulars (SoEP) (a requirement under the Environmental Assessment of Plans and Programmes Regulations 2004 - Regulation 16) setting out how the findings of the SEA have been taken into account and how views expressed during the consultation period have been considered as the SMP2 has been finalised will be prepared and will form part of the SEA Post Adoption Statement. The SoEP is not subject to QRG review and is not required prior to any approval.

### Water Framework Directive Assessment

A stand-alone Water Framework Directive (WFD) assessment has been undertaken in line with published guidance, this is at Appendix J. The SMP is in line with WFD considerations.

#### Habitats Regulations Assessment

For SMPs a Habitats Regulations Assessment (HRA) is required to establish the scale and implications of impacts of the proposed plan, and to provide a determination on whether a course of action is acceptable in terms of its impacts on the integrity of international environmental sites.

As part of the HRA undertaken for this SMP, an Appropriate Assessment was carried out. For the areas of this SMP in England and cross-border between England and Wales, the Competent Authority is the Environment Agency. For those elements which lie in Wales, the Welsh Government (WG) is the Competent Authority. It was determined that it was not possible to conclude that the policies within the SMP would not have an adverse effect on the internationally important sites in the area. Both Natural England and CCW confirmed their support for the proposed policies and agreed that there was a case for Imperative Reasons of Overriding Public Interest (IROPI). Natural England and CCW's letters of 28 September 2010 and 20 September 2010 (items 5a and 5b of approval bundle) explain their conclusions more fully.

Consequently an IROPI submission was made to Defra and WG. Confirmation that Defra and WG have no objections to proposed plan approval has been received (Items 9a and 9b of approval bundle), and the plan is compliant with the Habitats Directive.

#### **Action Plan**

The Action Plan sets out the actions required to implement the plan, and this will also be used to inform the CLG and Defra of any requirements relating to Local Authority performance (eg. National Indicator 189 or any successor). A key facet of the Action Plan has been to ensure that each action is achievable and is transferred to the Medium Term Plan (MTP) as appropriate.

The current Action Plan is a live document which will be regularly monitored by the Severn Estuary Coastal Group (SECG) and updated as required. Any updates will be published in place of the current Action Plan and held on the SECG website alongside the other SMP documents.

# **Erosion Mapping**

Coastal erosion risk information that takes account of updated Climate Change data (UK Climate Projections UKCP09) will be available over the next year and will need to be integrated into all the SMPs. The National Coastal Erosion Risk Mapping (NCERM) project team will produce a comparison report for each SMP to highlight whether there are any

changes to the preferred policy options as a result of the more recent climate data being used.
