4. SECG – Revised Terms of Reference

The terms of reference (attached) were agreed by the group following the amendment of the following correction: EA(Wales) and CCW should be replaced by NRW throughout the document. It was also noted that NRW is now the contributing member.

5. Election of Chair & Vice Chair

Dave Harris was re-elected as Chair of SECG (nominated by JB). As there was no nomination for Vice-Chair, it was agreed that requests for nominations would be circulated to members in readiness for a decision at the next meeting.

6. Severn Estuary Flood Risk Management Strategy

JB informed the meeting that the consultation had closed on 31 July. He suggested that there had generally been more positive comments from respondents to the revised consultation document this time. He explained that this may have been partly due to the reduction in SLR predictions, enabling a more flexible, longer term time frame for adaptation. JB also noted that since the initiation of the strategy there had also been a change in approach to flood risk management and associated funding, particularly partnership opportunities. It was also noted that SEP had assisted in the compilation of a summary document of the consultation responses, to be placed on the SEP website within the next month and to be circulated to all respondents.

JB informed the meeting that the finalising process of the strategy is currently in progress. However, he suggested that it would take a further 12 months at least for sign off.

7. Coastal Monitoring

The activities of the South West Coastal and Welsh Coastal Monitoring Centres were briefly outlined. The possibility of Phase 3 monitoring extending further up the estuary was noted. Issues associated with Welsh coastal monitoring were mentioned alongside the group's desire to see sharing of experiences related to new technologies between the South West and Welsh centres. In this context the opportunities of using Bathymetric lidar were briefly mentioned. DH also referred to the future of the Welsh Coastal Monitoring Centre in these discussions, noting the possibility that NRW may take over the role, following an invitation to tender for the role.

8. SMP2 Matters & Progress

IROPI

DH informed the group that he had been advised the SMP2 should be signed off by Welsh Government by Christmas.

Planning Leaflets – It was noted that the draft planning documents related to the SMP2 have been circulated to each authority by SEP. However, no comments on the documents have been received back. It was agreed that these documents should be recirculated and that SEP should coordinate feedback from planners and send this directly to Kath Wellard.

The meeting of the Sub-group, dated 10 Sept 2013, were noted. DH explained that gaps in the action plan still remain and he agreed to look through these with SEP prior to the next meeting.

9. Future of Bristol Channel Strategic Coastal Group

DH explained that there were three options for the future of the BCSCG:

- Continuation as usual
- The group to disband, with some coordination between groups, largely through meeting of Chairs & VCs of each group. This option, it was suggested could seek support from SEP for coordination.
- The group to disband with no coordination.

JB provided further context to the discussions, including explanation of the rationale for Defra's formation of 'strategic' coastal groups.

It was noted that the NDSCG had previously met and had already decided to withdraw from the BCSCG and to join the South West Coastal Group.

DH expressed the need for cross-border liaison associated with any new arrangements. As a minimum this should include the sharing of members and papers.

In the context of these discussions, it was agreed that discussion with the Swansea Bay Coastal Group would be useful.

10. National Coastal Chairs Group Minutes July 2013

Chair

DH summarised key items from the meeting, whilst encouraging members to consult the available relevant notes and papers.

Key aspects highlighted included:

- the presentation from Head of Licensing in the MMO which made reference to the Concordat between MMO, NE and EA. This sets out key principles for coordinating the consenting process for coastal development in England¹.
- the recent national overview of SMP2 outputs: recent monitoring indicates that 4% of actions are complete, but that there are many unspecified actions in SMP2s
- the approach to coastal change adaptation in W Riding, Yorkshire, using Partnership Funding
- Proposals for pilots to investigate issues associated with landowner maintenance of assets (particularly dredging and lowland drainage). Concerns include maintenance, meeting legislative requirements and liability issues. In the context of the latter, it was noted that EA lawyers are currently looking into this. DH also pointed out the establishment of the NFU Severn Estuary sub-group which is investigating these and other related issues.
- Reference to the need for a national review of habitat replacement under the Habitats Directive.
- EA website development which will include coastal flooding areas from January 2014 (including surface water flooding and defences)
